Position: Air Condition Maintenance

Purpose: This guide provides information about the process for the recruitment and selection of a Maintenance Company to look after and maintain all Air Condition Units within the Accident Compensation Corporation properties.

MAKING AN APPLICATION

GENERAL: Your Quote should include:

1. A short cover letter expressing interest in the Maintenance of Air Conditions and that you or your company has the expertise, skills, knowledge and ability in maintain any type or brand of air condition.
2. A Curriculum Vitae:
 - The history of you and your Company
 - Experience and Knowledge
 - Certified copies of your qualifications, trainings, professional affiliation and other documents provided in support of your application.
 - Your Contacts: mobile, landline, email and website
 - Include CV of your Employees
3. A copy of your 2024 Business License

REFEREE DETAILS: Provide written reference(s) from relevant businesses that you are working with.

AUTHORIZATION FORM: In signing the attached Authorization Form you are allowing the Accident Compensation Corporation to undertake the following checks:

- Approach in confidence the referees you have named and other people who have personal knowledge of you, to gather information related to your abilities.
- Security checks from the Ministry of Police and general security clearance with other agencies will also be undertaken.

TERMS OF CONTRACT: This is a 2 Year Contract with possibilities of extending for another 2 Years upon performance review.

QUOTES TO INCLUDE BUT NOT LIMITED TO THE FOLLOWING

1. Check and Fix the overall conditions of the air condition systems.
2. Check and Fix dirty or loose electrical connections, refrigerant leaks, malfunctioning safety systems or leaking seals around air handlers.
3. Inspect and Replace Filters.
4. Clean the Condensate Drains.
5. Clean Indoor Units.
6. Clear and Clean Outdoor Units.
7. Fix Insulation.
8. Replace and clean filters, coils, and fins.
9. Check refrigerant levels.
10. Schedule Annual Tune-Ups.
11. Schedule Monthly maintenance.
12. Urgent Calls.
